PARENTAL CONSENT RELEASE AND WAIVE OF LIABILITY - TO BE READ, UNDERSTOOD AND SIGNED FOR MINORS

BY PARENT OR LEGAL GUARDIAN, AND MINOR BEFORE PARTICIPATING IN ANY EVENT(S) OF XMR (X-treme Mountain Racing) ALONG WITH STANDARD WAIVER

For all MINORS allowed as competitors in any event(s) put on by XMR being allowed to enter any restricted area allowing only members of XMR with proper credentials each of the following items are understood for him/her, legal representative, heirs, or family.

1. I understand the nature of event(s) and the minors experience and capabilities, and believe the minor qualified to participate in the event(s). I will inspect the premises, facilities and equipment to be used and it is understood that each member and minor upon entering any restricted area will continuously inspect and observe all activities and if he/she or minor believes any situation or condition is unsafe in any way will advise the officials and will elect to leave the restricted area and refuse to participate in the event.

2. I understand the participation in any event(s) with XMR are VERY DANGEROUS and/or entry into Restricted Areas involves RISK AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, AND DEATH. Furthermore all risks and dangers may not be known to me and can be fault of the actions, or inactions of the minor, and I acknowledge the many risks known or unknown that could permanently affect the minors future socially and economically.

3. I ACCEPT ALL RESPONSIBILITIES FOR MINOR TO PARTICIPATE IN EVENT(S) AND/OR ENTRY INTO RESTRICTED AREAS OF XMR SPONSORED FUNCTIONS.

4. I/WE agree not to sue XMR, or any persons or companies associated with the event, including but not limited to officials, promoters, participants, associations sponsoring event, track owners, drivers, owners of drivers vehicle, pit crews, rescue personnel, owners or lessees of land utilized for event, driver sponsors, machinery owners, or anyone in any way associated

with any XMR event -- for any property damage, injuries or deaths associated with participating in any XMR event.

5. Agree overall to hold XMR an/or affiliates, directors, agents, employees, successors from and against all claims, liability

loss or expense, including attorneys fees which may result from the above.

I have read and understand all of the above and further understand that I have given up substantial rights by signing it, and have signed it freely and voluntarily without any inducement, assurance or guarantee being made to me and intend my

signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.
